From November 15-18, ACTA co-hosted CLAMISA 2022 - Latin American Food Congress: A Holistic View of Food Systems with the Agroindustrial Engineering program at Universidad Pontificia Bolivariana, ALACCTA (Latin American and Caribbean Association of Food Science and Technology) and IAFP (International Association for Food Protection). A great food event.

CLAMISA 2022 faced the challenge of combining three major events: XVI - CONACTA 2022: International Congress of Food Science and Technology; XXII - Latin American and Caribbean Congress of Food Science and Technology - ALACCTA and VIII IAFP Latin American Food Safety Symposium.

The objective of this event was to provide a space for the different actors involved in the creation and development of food systems to meet and exchange knowledge, know-how and experiences in order to contribute to the advancement of science, technology and food safety management as a fundamental factor for the productivity, competitiveness and sustainability of organizations, industries, regions and countries.

To this end, 12 thematic rooms were organized with outstanding speakers from Latin America, the United States and Europe. The rooms were organized as follows

1. Nanotechnology and food: no longer science fiction.
2. Consumer knowledge through sensory analysis is a necessity for the food industry.
3. New and not so new pathogens in food. How can we make our management systems

more "resilient"?

4. Healthy vegetables: a safety challenge

5. Packaging is a challenge for the food industry and the consumer.

6. The new focus on nutrition and health: the current challenge for food and beverage development.

7. Food integrity. The natural evolution in food safety management.

8. The silent pandemic: emergence and spread of antimicrobial resistance in Latin American food systems.

9. Food and nutrition security or sovereignty: from discourse to facts in post-pandemic times.

10. Analysis and perspective of food regulations in Latin America.

11. Food systems and climate change: between policy and action.

12. The value of data in food systems.

With an audience of 435 attendees and a program with something for everyone, we highlight the following plenary presentations:

- Global trends in food science: the route for a sustainable food system - Anne Rosales (IFT)
- A look at the future of food safety - Jairo Romero (IUFoST).
- Insect, microalgae and cell-farmed proteins: the impact of digestibility on the balance between sustainability and health - Vincenzo Fogliano (U Wageningen)
- Micro- and nanostructures in food - Humberto Hernández Sánchez (IPN - Mexico)
- Best processing practices: key strategy for product differentiation - Gerardo Gonzalez (TetraPak)
- New, and not so new foodborne pathogens - Managing Risks in a Field of Uncertainty - Michelle Danyluk (IAFP)
- Useful testing in risk-based Food Safety Management Systems from the ICMSF perspective - Leon Gorris

The event concluded with the panel Climate Change and Food Systems: perspectives and challenges.

As usual, ACTA promotes food research, and on this occasion Latin American prizes were awarded with a prize money of U\$18,000. The winners came from all over the world.

With this congress, we have once again reaffirmed our goal to transmit and share knowledge with our members (students, academia, government and industry representatives)
