Our early Sunday morning Affiliate meeting went extremely well and we almost finished on time. We had a large agenda to pack into the three hours allotted. Look for the meeting minutes on pages 12-13 of this newsletter and on the IAFP Web site.

Arising from this meeting were two recommendations to the Board of Directors. The first was to add pictures of Affiliate officers and other Affiliate pictures to the IAFP Web site. It was concluded that this was not feasible, due to space availability for each Affiliate on the IAFP site. Affiliates are encouraged to add pictures to their own Web site as there is a direct link from the IAFP site to the Affiliates' sites. The second recommendation was to obtain sufficient hotel space for future Annual Meetings. The Board recognizes the problem and pointed out that each situation is unique. They try to do their best in accommodating all attendees but the size of the meeting has reached a point where it is difficult to accommodate everyone in many cases.

This year the Affiliate Council Reception departed from the previously established norm of having a formal educational session as part of the reception. We took the approach of learning from each other. Each delegate at the reception was asked to discuss what sets their Affiliate apart from the others, or what have they done differently to increase their membership or improve their Affiliate for the benefit of the rest of the Affiliates. This was also an attempt at shortening a related section of the Sunday morning Council meeting agenda. The feedback on this new format and approach was discussed at the Council meeting. Although many expressed the benefit of this kind of evening, the consensus was to go back to the original format at next year's meeting. Our hearts go out to those on the Gulf Coast who suffered from Hurricane Katrina. ## IAFP 2005 Highlights

Baltimore welcomed 1,774 - a new attendance record - IAFP 2005 Annual Meeting attendees, and what a warm welcome it was! Attendees from 32 countries, 47 states, and eight Canadian provinces.

Sunday morning, August 14 started with a breakfast meeting for Affiliate Delegates. Many good ideas were shared, and IAFP thanks all who took the time to attend.



Outgoing Affiliate Council Chairperson, Stephanie Olmsted, passed the gavel to Terry Peters, who now will serve in that capacity for the 2005 - 2006 year. Maria Teresa Destro, University of São Paulo, Brazil was elected as Affiliate Council Secretary for the upcoming year. We extend our congratulations and best wishes to Terry and Maria Teresa in their new positions, and thank Stephanie for her excellent service to the group.

The educational program for the Annual Meeting started with the Ivan Parkin Lecture on Sunday evening, given by Dr. Douglas Archer, Professor and Past Chair, Food Science and Human Nutrition Department, University of Florida, Gainesville. Dr. Archer's presentation was entitled "Food Safety 2005: Results Come Easy - Answers are Elusive."

The first Student Travel Scholarships given by the IAFP Foundation were accepted by Stephen Grove, University of Tasmania, Werribee, Victoria, Australia, and Brooke Whitney, Virginia Tech, Blacksburg, Virginia. Expenses were paid for these students to attend the Annual Meeting. The IAFP Foundation plans to give a total of four total scholarships for the 2006 Annual Meeting in Calgary.

Six Fellows were awarded at this year's meeting. The recipients were: J. Stan Bailey, Athens, GA; Robert Brackett, College Park, MD; Joseph Frank, Athens, GA; Gale Prince, Cincinnati, OH; Jenny Scott, Washington, D.C.; and Susan Sumner, Blacksburg, VA.

Registrants had the opportunity to attend over 525 presentations, including 28 symposia, 80 technical sessions, and 287 poster presentations. There were also three well attended pre-meeting workshops and over 107 exhibitors for attendees to visit with.

Dr. Michiel van Schothorst, Retired Vice President, Food Safety Affairs, Nestlé, Vevey, Switzerland, gave the John H. Silliker Lecture on Wednesday afternoon, August 17. His presentation was entitled "Managing the Safety of Food in International Trade."

The Awards Banquet closed IAFP 2005. A total of 26 individuals and organizations were presented with awards and outgoing President Kathy Glass presented the gavel to incoming President Jeffrey Farber. Dr. Farber is with Health Canada, Ottawa, Ontario. Dr. Glass will serve as Past President on the Board of Directors for the 2005 - 2006 year.

IAFP 2006 will be held in the Telus Convention Centre, Calgary, Alberta, Canada. Preliminary information is available now if you wish to share it with Affiliate members and others. ## Meet the New Affiliate Council Secretary - Maria Teresa Destro

Olá todos! Can't understand what is written? Don't worry! It's just a Brazilian greeting and means "Hello everyone!" You may be wondering why I'm saying things in Portuguese?

Let me tell you: an outsider (me) was elected secretary of the Affiliate Council. Terry asked me if I'd accept the nomination and after some time trying to make up my mind, and with Stephanie's and Terry's support, I accepted the challenge. Just now, while writing this up, I realized that IAFP is always challenging me! The first was starting the Brazil affiliate (do you, David and Bob, remember our talk in Atlanta?).

Let me tell you a little bit about me. I'm the 5<sup>th</sup> child of a Brazilian/Italian family and as expected in any family of Italian background, everything happened around food. I am not sure if this or the fact that I was born while my father owned a bakery had any influence on my decision to go for food micro... (I'll never know that for sure, but we can start a bet guessing the cause and raise money for the Foundation Fund?!?!?). I got my BSc degree in Biological Sciences (Ecology) in 1980 at the Federal University of Sao Carlos and after that I worked for a year in my home city - Campinas, in a private lab that used to produce feed supplements. Then I moved to a governmental research institute - Food Technology Institute (Instituto de Tecnologia de Alimentos - ITAL) and there I was lucky to meet one of the most prominent Brazilian food microbiologists, Mauro Leitao. Mauro was my scientific guru, and he was responsible for my decision to be a food microbiologist.



My MSc was in Food Technology at the University of Campinas (1990) and the PhD was in Food Science at the University of São Paulo - USP (1995). Before finishing my MSc I applied for a position as "teaching auxiliary" at the Department of Food and Experimental Nutrition (FBA) of the Faculty of Pharmaceutical Sciences of USP and was chosen. Since then, I've been teaching food micro at FBA, however, in a different position and I've also been counseling undergrad students, MSc dissertations and PhD theses.

I had two international experiences: during my PhD I spent several months at Health Canada working under Jeff Farber's supervision and, in the beginning of 2000, I took a sabbatical and spent a year at the Division of Food Science at the University of Nottingham, England.

IAFP appeared in my life in 1994 via Jeff (it was IAMFES at that time) and I became a member while in Canada. IAFP meetings always appealed to me and in 1999 I finally made my debut in Dearborn, Michigan (I chose the right venue, don't you think so?!?!). Since then I've been attending all

the meetings, with or without official funds, because for me the IAFP Annual meeting is a "must go". It is the time of the year to meet "old" friends, to make new ones, to discuss projects, and to learn a lot about food safety.

What else can I say about myself? That I'm attracted to challenges? That I love teaching? That I'm pretty intense in what I do? That friends and family are really important for me? I have no clue, so let's make a deal: you may ask me whatever you want to know, OK?

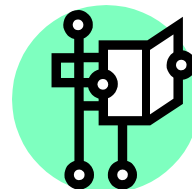

**Meeting called to order:** 7:20 a.m.

**Recording Secretary:** Terry Peters

- Call to Order:** The meeting was called to order at 7:20 a.m. by Affiliate Council Chair Stephanie Olmsted. A sign-up form for attendees was distributed to delegates and guests. There were 39 members and guests present.
- Roll Call:** A roll call of the Affiliates was conducted. Stephanie recognized the presence of the newest Affiliate Delegate, Roger Cook from New Zealand. The official charter will be presented to Mr. Cook during the Association business meeting.
- Minutes:** The minutes of the 2004 Affiliate Council Meeting were reviewed by the delegates present. Motion by John Bruhn, seconded by Fred Weber, to approve the minutes as presented. Motion carried. John Bruhn, California Affiliate, recommended that all action items be included in the minutes.
- Executive Board Report:**
  - Kathy Glass, Executive Board President, reported on the activities of the past year. In summary – Membership is stable.
  - The Association is “financially in the black” and therefore new programs can be defined.
  - A Membership Committee has been established to talk about the issues of retention and attracting new members.
  - A dues restructuring is being discussed.
  - There are 79 Sustaining Members, including 9 Silver Sustaining Members and 4 Gold Sustaining Members.
  - There are now 10 Affiliates outside of the United States. New Zealand is the most recent, and groups in India and Japan have expressed interest in becoming Affiliates.
  - This year about 75% of manuscripts were submitted on-line, as well as about 75% of all annual meeting registrations were completed on-line.
  - Two new committees are being explored this year, one on food law and the other on beverages.
  - The Foundation Fund has assets of \$320,000 and the goal is to have \$1,000,000 by the year 2010, to support more programs.
  - Student scholarships will be increased in the next year with one more scholarship being given to a student from the US or Canada, and another being given to a student from a developing country.

The first full symposium sponsored by IAFP outside of the US will be held in Prague in October 2005.

All Affiliates were reminded of the Officer Speaker Program and that they should take advantage of this as much as possible.

Stephanie Olmsted acknowledged the great work and dedication from Kathy Glass in the past year.

**IAFP Office Report:**

David Tharp reminded the delegates that in order for an Affiliate to be compliant, both the president and delegate must be members of IAFP. There must also be five other members of the Affiliate who are IAFP members. Also, each Affiliate must submit an annual report. The office staff works with the Affiliates to see that they are compliant.

David also reported that the numbers of registrants for this annual meeting are estimated to go over 1,700. He commented that the association is in the best financial shape it has ever been in and that the fundraising efforts for the Foundation will work to benefit the entire association and will help "bring more people into our world of food safety." The good financial position will allow more flexibility in programs and activities in the future.

Nancy Herselius stated that she would like to see more information from Affiliates to include in future newsletters. Suggested was information from Affiliate meetings, as well as pictures. Also, if there are topics that are of interest to Affiliates that can be covered in the newsletter, those should be passed along.

**Election of the Affiliate Council Secretary:**

Terry Peters nominated Maria Teresa Destro, Brazil Association for Food Protection, as the new Affiliate Secretary. This nomination was seconded by Fred Weber.

Stephanie Olmsted asked for nominations from the floor. Hearing none, nominations were closed.

Motion by John Bruhn, seconded by Carl Custer, to approve the nomination of Maria Teresa Destro. By voice vote, the motion was carried.

**Affiliate Educational Reception:**

There was a different format this year due to the withdrawal of a possible speaker late this spring. This was viewed as an opportunity to have more of an international flavor and an opportunity to learn about other Affiliates at the meeting. The question posed to the delegates was whether they would like to repeat this format or if they would like to have a speaker on an educational topic next year. Two delegates, Fred Weber and Peter Hibbard, stated that they definitely would like to continue to have an educational speaker, and this appeared to be the desire of the Council.

Questions about securing a speaker arose. David Tharp commented that when this was started, it was to be the Affiliate local to the meeting site that would be responsible for finding the speaker as well as securing funds for the reception. The Affiliate Chair and IAFP staff can work on this, but they need the input from the local area.

All sponsors of the Affiliate Educational Reception – Capitol Vial, TetraPak, Warren Taylor Services, and Weber Scientific – were thanked.

**Unfinished Business:**

Maria Teresa Destro, Brazil, suggested that it could assist Affiliates if IAFP provided a link to *JFP's* Table of Contents and abstracts. David Tharp commented that there is no need for special permission, that Affiliates may add this link to their site at will.

Fred Reimers, Texas, stated that he would like to see information and pictures from each Affiliate's Meeting at the IAFP Annual Meeting to help increase membership within the Affiliates. He also suggested that pictures of the officers, individual or group, as well as pictures of events, be added to Affiliate web sites. This would provide, says Reimers, a more personal feel to membership with an Affiliate. Nancy Herselius is to work with the Affiliates to facilitate this.

Brian Cecil, Michigan, stated that he would like to be able to e-file annual reports, sending pictures of meetings and such with them.

Motion by Fred Weber that the Affiliate Council recommends having digital pictures and information regarding Affiliates available on the IAFP web site and that Affiliates provide the pictures as part of their annual report. Seconded by John Bruhn.

The question brought up was whether or not this would be mandatory for all Affiliates. John Bruhn suggested that there be options presented to the Executive Board on how to approach this idea. Carl Custer, Capital Area, suggested that some Affiliates may need help with building their own web sites.

Motion by Carl Custer that an amendment be added to the previous motion stating that the submission of pictures and Affiliate information to IAFP be on a voluntary basis. Seconded by Hashavardhan Tippareddi, Nebraska.

The amendment passed unanimously. The original motion also was passed unanimously.

**New Business:**

David Tharp commented on the dues collection process. The IAFP office collects dues for some Affiliates, but not all. He stated that while this practice can be continued, it can be confusing for some Affiliates who do not collect

Passing of the Gavel: Chair Stephanie Olmsted passed the gavel to Terry Peters signifying the beginning of his term as Affiliate Council Chair.
