This study had been prepared by Nielsen Turkey for Turkish Food Safety Association in order to understand to what extent product labels on packaged foods are examined by Turkish consumers, how comprehensible they are attributed, and consequently the impact on the purchase decision, consumption decision and food waste.

Within the scope of this study, 1545 women and men, between the ages of 18-65, who are responsible for grocery shopping in the household, who fall within ABC1C2DE SES, residing in selected 26 provinces in seven regions within IBSS Level 2 and representative of Turkish population were personally interviewed using the CAPI method.

TFSA actions as a result of the research

- Doing awareness raising activities for the consumers about label reading and preparing guidelines
- Preparing guidelines on Expired Date and Best Before Date for producers
- Providing shelf life training for producers
- Preparing a guide for consumers about cooking and storage, and informing consumers
- Awareness raising activities for consumers
- Dissemination of the methods of selling the products of which expire date is approaching with the information on the special shelves
