 - Richard Brouillette on the topic ‘Partnership of OEM, Processors, and Equipment Design’.

4. Topics for IAFP 2020 Preparation:

- a. Symposia Suggestion: Jeff K. Founders of food safety - more of general interest. Historical time line, selected contributions to food hygiene- maybe with Education PDG, and student pdg, family tree concept. Where have we come from and where are we today?
- b. Workshop Suggestion: Jeff K. How do you validate the cleaning of a piece of equipment? What are the steps that need to be performed? How can you design a validation program?
- c. Symposia Suggestion: Yale Larry. OSHA and Sanitation – How can you effectively design a sanitation program that also factors employee safety and chemical safety. The PPE needed, exposure duration, removal of fats and soluble proteins and addressing blood borne pathogens.
- d. Symposia Suggestion: Rick Stokes. Using sanitation microbiology data to resolve sanitation issues. How to use data to drive sanitation program changes?
- e. Symposia Suggestion: Ruth Petran. Biofilm topic in as a general category for discussion. Re-cap the 2019 session and determine a continuation on the biofilm topic.
