The 8th International Food Safety Congress

The 8th International Food Safety Congress has been realised with great success alongside your valuable support, with the participation of over 450 participants including guests from 12 different countries. The Congress has established a very effective information sharing platform where we could catch up with, discuss and share information on recent developments of food safety at global and local level.

Mission statement for meeting (if relevant);

As the Turkish Food Safety Association, we have been organizing Food Safety Congresses since 2009 and the 8th Food Safety Congress was held on 8-10 May 2024 in Istanbul, Turkey. The 8th International Food Safety Congress was organized in collaboration with the International Association for Food Protection (IAFP). 36 professional organizations were involved in the organization of the Congress as Congress stakeholders.

The Food Safety Congress is the only congress in our geography covering Turkey, Eastern Europe (Balkans), Ex-soviet countries and the Middle East specifically dedicated to the issue of food safety. The primary mission of the Food Safety Congresses is to raise awareness on the food safety issue and to create a common ground for those who are dealing with food safety from different groups and professions like food scientists& technologists, agricultural engineers, veterinarians, medical doctors. The Food Safety Congresses also aims to bring new concepts and novel approaches related to food safety to the agenda of decision-makers, scientists and food/health professionals.

Keeping in mind the fact that food safety has strategic importance on the protection of the consumer, on the development of the agro-food sector and on the regional/global economy. Also, food safety is a dynamic concept. Therefore, exchanging knowledge and information between all stakeholders of food safety is of critical importance in establishing a well-working food safety system. Moreover, our 7th Congress was honored with the "2023 Best Meeting Award" by the International Association for Food Protection – IAFP.

The 8th Food Safety Congress created an environment to set up a common sense among food safety professionals from different professions and different institutions both public and private. The Congress Statement which included recommendations for safer food and better health in the future also was released.
