Old Business: Approved 2025 FVSQ PDG Meeting Minutes.

New Business: The PDG Vice Chair Adam Baker, introduced the new Student Liaison Officers (Precious Aduloju & Juan Gao). Precious Aduloju provided an update on student PDG activities and initiatives. The FVSQ PDG served as the primary sponsor of five symposia and a secondary sponsor of one roundtable at the 2026 IAFP Annual Meeting. A live poll was conducted to assess members' experience in food safety and quality, as well as their reasons for participating in the FVSQ PDG. Vice Chair Adam Baker called for nominations for an industry representative to serve as the next FVSQ PDG Vice Chair starting July 18, 2026.

Presentation updates were provided by Dr. Betsy Bihn on Produce Safety Alliance (PSA) activities, including PSA's objective of establishing a fellowship program in the Northeastern United States. Dr. Kristin Butler presented FDA Produce Safety updates, and Dr. Brooke Whitney provided an update on the CORE Network.

Following the presentations, members participated in a networking session and brainstormed ideas for symposia and roundtables for the 2027 IAFP Annual Meeting. A dot-voting exercise was conducted to identify the most preferred topics from each discussion group.
