

IAFP VIRTUAL PROGRAM CODE OF CONDUCT

IAFP is committed to providing a safe, productive, and welcoming environment for all meeting participants and IAFP staff. All participants, including, but not limited to, attendees, speakers, volunteers, industry partners, exhibitors, IAFP staff members, service providers, and all others are expected to abide by this Virtual Program Code of Conduct. This Policy applies to all IAFP meeting-related events, including those sponsored by organizations other than IAFP but held in conjunction with IAFP events, on public or private platforms.

IAFP has zero-tolerance for any form of discrimination or harassment, including but not limited to sexual harassment by participants or our staff at our meetings.

If you experience harassment or hear of any incidents of unacceptable behavior, IAFP asks that you inform David Tharp, IAFP Executive Director, dtharp@foodprotection.org or +1 515.276.3344 so that appropriate action can be taken.

Unacceptable Behavior is defined as:

- Harassment, intimidation, or discrimination in any form.
- Verbal abuse of any attendee, speaker, volunteer, industry partner exhibitor, IAFP staff member, service provider, or other meeting guest.
 - Examples of verbal abuse include, but are not limited to, verbal comments related to gender, sexual orientation, disability, physical appearance, body size, race, religion, national origin, inappropriate use of nudity and/or sexual images in public spaces or in presentations, or threatening or stalking any attendee, speaker, volunteer, industry partner, exhibitor, IAFP staff member, service provider, or other meeting guest.

In addition, participants are asked to adhere to the following rules:

- The recording or transmission of any education sessions, presentations, demos, videos, or content in any format is strictly prohibited.
- Disruption of presentations during sessions, in the exhibit hall, or at other events organized by IAFP throughout the virtual meeting. All participants must comply with the instructions of the moderator and any IAFP virtual event staff.
- Presentations, postings, and messages should not contain promotional materials, special offers, job
 offers, product announcements, or solicitation for services. IAFP reserves the right to remove such
 messages and potentially ban sources of those solicitations.
- Any direct selling of products or services offered by speakers, industry partners, or consultants in any
 public area of the virtual platform is prohibited. Many conversations are based around knowledge and
 expertise and are not categorized a direct sales pitch. Selling must be conducted during mutually
 agreed upon private video, audio, or text conversations.
- Participants should not copy or take screen shots of Q&A or any chat room activity that takes place in the virtual space.

IAFP reserves the right to take any action deemed necessary and appropriate, including immediate removal from the meeting without warning or refund, in response to any incident of unacceptable behavior.

IAFP reserves the right to prohibit attendance at any future meeting, virtually or in person.
