**QUALIFICATIONS** | B.A. in Microbiology, Rutgers College; Ph.D. in Microbiology, University of Miami; Post Doctoral Researcher, State University of New York, Stony Brook; Senior Staff Fellow, National Institutes of Health, National Institute for Neurological and Communicative Disorders and Stroke.

**CAREER HIGHLIGHTS** | Keith was born and raised in New Jersey. After graduating from college, he headed south for graduate school. His post-graduate work focused on bacterial genome evolution, and he continued on to studying sporulation at the molecular level. In 1987, he joined the FDA as a research microbiologist and began his career working with *Shigella* and other foodborne pathogens. Keith is also an adjunct professor at several local universities and has taught classes in biology and microbiology. Throughout his tenure as a researcher, Keith has mentored more than 70 high school, undergraduate and graduate students.

Other professional activities include serving as a journal reviewer (e.g., *Journal for Food Protection*), and as a panel member for the USDA and NIH SBIR study sections. He has also served on several advisory committees and boards, including the UN Joint FAO/WHO Expert Committee on Food Additives (JECFA).

**PORTFOLIO** | Keith currently serves as the President of the Capital Area Food Protection Association (CAFPA). Since becoming an IAFP Member in 2006, he has joined several PDGs and organized several symposia with an emphasis on issues that reflect on global food safety. His involvement with CAFPA includes organizing short symposia with a wide range of topics, and locating speakers who address current food-related issues, such as the topic of raw milk consumption. Future projects within CAFPA will entail the establishment of a mentoring program with young professionals who will spend time with food safety experts within the region, as well as planning a mid-Atlantic meeting with other IAFP Affiliates.

# New York State Association for Food Protection

### **Celebrating Nine Decades!**

The handful of men who met under the stairway of the dairy building at the New York State Fair in 1923

to establish the **New York State Association of Milk and Dairy Inspectors** would be astonished and delighted to see what has become of their brainchild. These men were establishing a professional organization of government control officers, which included representatives from industry and academia.

In 1923, there were over 120,000 dairy farms in New York, shipping milk to over 3,000 milk and cheese factories, with about a third of the amount going to New York City. To assure that milk would remain safe throughout the time period from production to consumption, political sub-divisions developed sanitary control ordinances and regulations, often with conflicting requirements.

The leaders of the day recognized these problems and wanted to pro-

fessionalize the work of the dairy inspectors, keeping them up-to-date on new developments, while providing a forum for disseminating technical information and quality, as well as a means of exchanging ideas and experiences. Thus the **New York State Association for Food Protection (NYSAFP)** got its start 90 years ago in Ithaca, NY. Emmett R. Gauhn, Rochester Bureau of Health, was elected President and Thomas J. McInerney, Cornell University professor, became its first Secretary-Treasurer. Mr. Gauhn served for four years, during which he built a strong foundation for the future. Since then, 85 Affiliate Presidents and nine Secretaries have served.

Since that first meeting when a mere seven people attended, membership grew to 568 in 1941, with 428 participants attending the Annual

Meeting. With World War II travel restrictions and many people serving in the military, attendance declined, forcing some meetings to cancel. However, participation recovered quickly after the war.

Several name changes took place as the industry and the responsibilities of the inspectors developed. The Affiliate was initially called the **New York State Association of Milk and Dairy Inspectors**, switching to **Milk Sanitarians** in 1942. By 1965, it was referred to as **Milk and Food Sanitarians** and in 2001 was re-named to its present title to better reflect the current focus of the organization.

NYSAFP had the honor of hosting the IAFP Annual Meeting on two occasions, the first in 1958 in New York City, and the second in 1973 in Rochester – the same year that our Affiliate celebrated its 50th Anniversary and that the International Association for Milk, Food and Environmental Sanitarians (IAMFES, now IAFP) celebrated its 60th Anniversary. More than 300 participants attended the joint celebration banquet that year. At that time,

NYSAFP had 852 Members, with 153 holding joint membership with IAMFES. A total of fourteen affiliates throughout the State also served the needs of local members.


Our award-winning quarterly newsletter, aptly called the *Newsletter*, was created in May 1957 as a 13-page mimeographed document. Donald Race, co-author of the Association’s history, served as its first editor for eight years, setting the standard of excellence. For many years, the *Newsletter* carried a four-page supplement to also provide news from the Connecticut Association of Dairy and Food Sanitarians. Amazingly, John Bartell, Professor Emeritus

from Alfred State College, is currently in his 38th continuous year as editor of the *Newsletter*.

A notable spinoff of the Association was the popular Farm Practices Committee, with members from throughout the Northeast dealing with issues of uniformity of regulations. It was thought that it could better serve its goals by becoming a separate and independent organization; thus, the Northeast Dairy

Practices Council (NDPC) was formed and included 11 states led by Chairman Richard March. The NDPC produced more than 50 guidelines and developed a sound national reputation. In 1994, the NDPC transformed into a national organization, now known as the Dairy Practices Council. Meanwhile, a very active Farm Methods Committee carries on its work in New York State.

To encourage young people to become involved in the Association, as well as in the dairy and food industry, a scholarship committee was established, with \$1,500 being raised and two \$500 awards presented in 2004. Since then, 16 scholarships have been awarded, with the current amounts set at \$750 each.



And so it is. The 90-year history of the New York State Association for Food Protection is chronicled in *The First Ninety Years...1923–2013*, a 148-page document. Three hundred copies were printed for the 90th Anniversary celebration held at our **90th Annual Conference** on September 17–19. This clearly shows how our Association has met the needs of the dairy and food industries and has provided opportunities for industry, regulatory and academia to meet quality and safety requirements throughout the Northeast and beyond. We are in a strong position to continue these efforts as we approach our centennial anniversary and well beyond.

### BCFPA Speaker's Evening: Three Insightful Presentations

More than 40 members attended the **British Columbia Food Protection**



#### Association (BCFPA)

Speaker's Evening event to hear *Keep Your Business from Going Viral!*

*Understanding and Controlling Norovirus.* The event was held May 9 at the Shadbolt Centre for the Arts in Burnaby.

Prior to the presentations, attendees had a chance to network and view sustaining members' displays while enjoying a delicious assortment of appetizers. The program opened with **Alex Montgomery**, BCFPA President, welcoming everyone and outlining the program for the evening.

**Dr. Natalie Prystajeky**, BC Centre for Disease Control, began the educational part of the evening with "It's Gone Viral: Emergence of Norovirus GII.4 Sydney in BC." She gave an overview of the prevalence of Norovirus in BC and worldwide, explaining why the virus is environmentally tough and emphasizing the importance of molecular sequencing

in understanding the circulating global Norovirus strains.

Following Dr. Prystajeky's presentation, attendees enjoyed a break with opportunities to network and visit display booths. During this time, the 50:50 and door prizes were drawn.

The evening's second presentation, "Time's Up! Cleaned Up?" featured **Graham Monda** with Rochester-Midlands. In an interactive audience session, Graham discussed implications of food soils and pathogens in the food production facilities, pointing out that choosing the right sanitizers and sanitation procedures are highly important in ensuring food safety.

The evening's final presentation was by **Stephanie Chiu**, a recent M.Sc. Graduate from UBC. She presented her Master's project, "Efficacy of Common Disinfectant/Cleaning Agents in Inactivating Surrogate Viruses for Human Norovirus." Her research showed that bleach is the most effective in reducing viral loads when compared to products based on quaternary ammonium compounds (QUATs) or accelerated hydrogen peroxide.

BCFPA extends its thanks to the three speakers for taking time to present at this most successful and educational event.

### Texas Association for Food Protection: Annual Event a Success

The 32nd Annual Meeting of the **Texas Association for Food Protection (TAFP)** took place June 3–5 in Austin, starting off with a well-attended golf tournament at the Grey Rock Golf Club, combining industry and vendors. Everyone walked away with a prize and, with 32 hole sponsors, \$5,780 was raised for the Association.

The meeting began on Tuesday with a welcome from Past President **Damon Miller**. **Mariana Villarreal** from Texas A&M then gave an update on scholarships, announcing that during the past year, \$10,000 was awarded in scholarships for students from Texas A&M and Texas Tech (\$5,000 each).

**Dr. Gary Acuff**, Texas A&M, then presented on managing risk with performance objectives. **Joe Dirksen**, Ecolab, followed with his presentation on cleaning processes in dairy plants, and **Matt Taylor**, Tex-

as A&M, talked about effective uses of antimicrobials in shelf life.

Following lunch, **Tori Stivers**, University of Georgia and IAFP Representative, gave an excellent presentation on seafoodborne illness in the U.S.

Presenting next was **Frank Barcellos**, who gave the annual NCIMS update. The day ended with an update from **Dr. Rod Moline** from the Texas Department of State Health Services, followed by a barbeque dinner and dancing to live music at the Creedmore Community Center.

Wednesday began with a producer update from **Dr. Robert Hagevoort**, NMSU Extension Specialist, and continued with a presentation from **Dr. Ellen Jordan**, Texas A&M, who spoke on animal drug residue testing. The final presentation was a panel discussion on FSMA, moderated by **Dr. Allen Sayler**, Center for Food Safety and Regulatory Solutions, and included industry representatives from Borden's, Blue Bell and H-E-B. A half-day training session led by Dr. Sayler combined an FSMA short course and information on what to do when the FDA appears at your door.

The Business Meeting concluded the day. **Brian Miller** was elected TAFP President, and **Damon Miller** was elected Past President/Vice President. Other officers on the board remain the same.

### Florida Association for Food Protection: Educating and Having Some Fun!


This year's social event brought conference attendees together for an evening of bowling at the AMC Lanes in Kissimmee. Amidst the laughter, we

### Africa Association for Food Protection: Annual Meeting Held During IAFP 2013

The **Africa Association for Food Protection (AAFP)** met on July 29 in Charlotte, NC during **IAFP 2013**. Accomplishments during the past year included five meetings held by the AAFP Executive Council (one in-person and four utilizing Skype and GoToMeeting) to work on developing the infrastructure for the Affiliate.

Utilizing funds donated by members of the Executive Council, a

website developer was engaged to build a website. The first site proved unsuccessful; however, a new site was eventually established (<http://africanfoodsafety.com/>). **Nenge Njongmeta**, Vice President, demonstrated the new website and encouraged all attendees to register as 'students' through the site, as all memberships will currently be considered 'student' memberships, for which dues are not required. Sufficient funds were contributed to support the website for another year, allowing the Executive Council to defer collection of membership dues during this time.

The Executive Council also succeeded in establishing a U.S. dollar bank account for the Affiliate through Eco-bank in Ghana. Funds from membership dues and contributions can now be accepted, as well as monies sent to IAFP and, if earmarked for AAFP, can be sequestered for the Affiliate's use.

IAFP can accept contributions online or by phone.

After the formation of AAFP, the Executive Council decided to incorporate in the U.S. (in Illinois) as a 501(c)(3) nonprofit for the required \$500 fee. This fee was raised at the meeting through contributions and pledges.

President **Charles Muyanja** reported on the 2013 Affiliate Council Meeting that he attended as the representative for AAFP, describing the obligations of an affiliate, including requirements under the Bylaws of IAFP. He also spoke about the benefits that IAFP provides to its affiliates, including the Executive Board Speaker Program and support for webinars.

Future plans include dividing members into geographical regions (Northern, Western, Central, Eastern and Southern Africa) and appointing two representatives per region. These regional representatives would then be asked to attend larger AAFP meetings

throughout the continent. It is also hoped that AAFP members will organize regional food safety meetings.

AAFP leaders have been talking to ministries of health in several countries, as well as WHO/FAO to increase the Affiliate's visibility; however, more work is needed. Attendees were encouraged to spread the word about AAFP to increase membership.

In addition to public relations and membership recruitment efforts, AAFP leadership plans to get the board and committees operational during the next year and work on developing a Constitution and Bylaws. An audit of the Affiliate's accounts will also be commissioned when appropriate.

Members were encouraged to share their suggestions to help move the Affiliate forward and offer topic ideas to the board for discussion at future meetings.

AAFP leadership was encouraged to keep communication open and active with members to promote interest in the organization's initiatives.

**Peter Kennedy** volunteered to coordinate a sponsorship drive to help increase revenues.

**Edgard Parfait Nemorin** from GFSI invited AAFP to appoint a representative to attend the GFSI Focus Day on September 11, 2013, at its expense. Other suggestions from attendees included:

- Create a LinkedIn group to facilitate communication (*completed*);
- Begin distribution of a monthly newsletter. Members can take turns contributing articles on food safety topics relevant to their country or region; and
- Establish a student committee.

she volunteered as an instructor for the FDA's Retail Food Plan Review Course throughout the U.S., prior to the privatization of the course.



**Call to Order:** The meeting was called to order at 7:04 a.m., Sunday, July 28, 2013 by Chairperson Tori Stivers. The agenda was approved without addition/changes (so moved and seconded). Susan Smith called the roll.

**Change of the Minutes:** Minutes from the 2012 Affiliate Council meeting were amended with the addition of Jenny Scott, Capital Association for Food Protection, to the list of "Affiliates Present."

**Approval of 2012 Minutes:** The amended minutes were then approved and seconded.

**Report from Affiliate Chairperson:** Glad to see IAFP Affiliate has grown over the years and appreciated the opportunity to serve as the chairperson of the Affiliate Council. Mentioned the changes regarding annual reports. A new format for submitting annual reports was developed in 2013 simplifying the preparation of the report. Would like to hear feedback from the delegates regarding the new reporting format. Reminded the delegates regarding the requirements as IAFP Affiliates: Affiliate Presidents and Delegates are required to be IAFP members. Submission of annual report. Meet annually or at least once within a period of two years. Conduct affiliate affairs in accordance with the Constitution and Bylaws of IAFP. Acknowledged Gloria Swick-Brown as the Affiliate Council Past Chair and as a recipient of the 2013 IAFP Honorary Life Membership Award. Acknowledged the Carolinas Affiliate and Ben Chapman for leading the Local Arrangement Committee efforts for this year's IAFP Annual Meeting and for their hospitality.

**Report from IAFP President:** Katie Swanson welcomed the delegates and guests and made the following remarks: The attendance at IAFP 2013 reached a record number with more than 2,800 attendees registered prior to the opening of the meeting. The attendance for IAFP 2012 was 2,540. Affiliate Council members of the Board provide the voice of the members which is vital to the organization. Affiliates represent the ground troops to make sure food safety gets implemented at the local level. Thanks for all you do as delegates and do not hesitate to volunteer to serve as a Board liaison. We need the input. Thanked Tori for her work and leadership as Chairperson of the Affiliate Council. It's a good idea to bring board members to speak at your meeting. The board will pay the Board Member's travel to and from the meeting, and the affiliate pays for local costs. It is a great way to add technical content to your program and perhaps illustrate the benefits of joining IAFP. IAFP signed an MOU with international organizations, like FAO. FAO would like to work with IAFP to provide an expert to help with training in developing regions such as Africa. We are also working with other regions trying to grow our affiliates around the

world. We need State and local departments of health and agriculture regulator input at the ground level because their perspectives are vital to food safety effort. We are providing travel funds to have select representatives to travel to IAFP. The Foundation also added travel funds for a scientist from a developing region because we need to connect to the developing region. David Golden is retiring as editor of *Food Protection Trends*, and Cathy Cutter will be taking over those duties. If you have anything in your regions to communicate in print, please submit articles to *FPT*. This not only increases the visibility of your work but also allows others to learn about your regions. IAFP had many international meetings in France, Peru, China and Dubai. We are hoping to add three Latin American Affiliates. The Taiwan Affiliate is organizing the 3rd Asia Pacific International Food Safety Conference to be held in Taipei, Taiwan, Oct. 29 – Nov. 1, 2013.

**Report from IAFP Executive Director:** David Tharp welcomed the Delegates to Charlotte and acknowledged the work that the Affiliates have accomplished in promoting food safety and the IAFP. He reiterated the availability of the speaker program and encouraged the Affiliates to utilize this resource. IAFP will try to accommodate the requests for speakers. David commented that it is exciting to see the continuing growth of IAFP internationally. Financially, IAFP is doing well and since last year, it has over \$1 million in the general fund. This year's Annual Meeting is a success and will exceed past attendance records.

**Report from IAFP Staff Liaison Staff:** Susan Smith reported the following:

maries of their meetings with good quality photos and website info. If you are interested in being highlighted in the *Biobrief* column of *Affiliate View*, please let Susan know. This is a great chance to brag about your Affiliate's accomplishments and successes.

**Roundtable Discussions:** Twenty minutes were devoted to roundtable discussions. Suggested topics included: 1) how to attract new members, retain current members and find officers to serve; 2) speakers, program responsibilities, and budget for meetings; and 3) recordkeeping including Annual Reports to IAFP, affiliate award application, member lists, and tax reporting. One person from each table briefly relayed their group's discussion to the entire gathering, as summarized below:

*Peter Hibbard* – Ways to attract new members include hosting an annual meeting, utilizing large company contacts, and reaching out to universities with food safety programs. To retain current members, Affiliates can consider hosting fun and engaged annual meetings and luncheons (half time with lunch included) with topics to share. Have a core group of directors/members to draw from as officers and utilize students and collaborate with them and their universities. To encourage participations at Affiliate-sponsored meetings, a survey of meeting attendees can be conducted to determine the topics of interest for the next meeting. Emails can be sent to other groups and individuals that might not have been involved in the past to capture their feedback. Incoming president has responsibility to organize and drive next year's

annual meetings. Have bylaws developed to support who is in charge of meeting programs. With respect to budget, the registration fee needs to cover cost of meeting. Need to engage corporate sponsors and have exhibitors at annual meetings. Regarding the feedback of the reporting process, the group feels the new format is more structured and easier to use, and everyone has a positive view on this.

*David Lloyd* – Having annual meetings is important for attracting new members. Corporate members play an important in attracting people. Student involvements are also important. Some attendees would like to have a certificate indicating their participations at affiliate meetings. [David Tharp noted every state has its own rules about providing certificate of continuing education credit for attending affiliate meetings. IAFP does provide such certificates to meeting participants, if requested.] To retain members, it is good to have a successor planning especially for the older affiliates. Get local food sponsors to support your meetings. The UK has had speakers from across four countries. Next year, they would like to target US speakers. For meeting programs, it is important to have a group of people (e.g., organizing committee) across several organizations involved in the planning. It is good to have surveys conducted after meetings.

*Li Maria Ma* – To attract student members, Affiliates can establish student committees. Professors can bring students to attend the Affiliate meetings. Make IAFP more visible to college students majoring in Food Science. Suggest putting IAFP meeting program on

the web so others outside can view.

*Ian Jenson* – One way to attract new student members is to visit universities and invite students to attend the Affiliate's annual meeting to present their work. Such experience provides a good record of achievement on their CV/resume. Another way to attract new members is to invite colleagues and professional contacts to attend Affiliate meetings. Membership fees for new members cover an extended time, including the remaining time of the year plus a full year following.

*Isabel Walls* – One way to retain members is to offer workshops and educational programs. Good to use IAFP webinars but need subtitles in local languages or translated. Consider time zones so people outside of US can participant at reasonable time. Existing webinars can be translated to other languages. This translation effort can be achieved by utilizing international students. In return, IAFP can sponsor the students' travel to attend IAFP Annual Meeting. Financial support for this translation effort can also include collecting funds from universities, membership dues, industry donation, or partnership with other associations.

*Michael Schoenherr* – Have Affiliate meetings scheduled for daytime *and* evening hours to allow people with different schedules to attend. Depending on states, it is hard to attract regulatory or industry members to participate at meetings. However, providing

CEUs to sanitarians for participating at Affiliate meetings has been a positive item. Use IAFP webinars to reach out to the industry and in the meantime draw their interests to the Affiliates. Organizing workshops or meetings takes time, having one to three workshops per year seems to be a good number. Regarding tax reporting, it is a complicated process. Florida Association for Food Protection (FAFP) hired a consultant from H&R Block to help with this process, and the effort is still ongoing.

**Follow-up discussions:** Bylaws: Eric Martin mentioned the process of developing their bylaws. He invited anyone who is interested to visit their website and take a look at their bylaws. Other Affiliates are welcome to adopt FAFP's bylaws. Susan Smith reminded the delegates that affiliates must comply with IAFP bylaws. But Affiliates bylaws can be adapted to meet their respective needs.

**Webinars:** Tori suggested that Affiliates utilize IAFP webinars as a resource for their local meetings. The New Zealand Affiliate held a workshop using a recorded IAFP webinar, but felt that it is different from the live one where questions can be asked. It was suggested that future webinars consider the time zones so that international Affiliates can participate live. Suggestions were also made to have the IAFP webinars in different languages. Bobby Krishna suggested that webinars can be broadcast as a Podcast. Don Zink mentioned that the FDA has the capacity to provide webinars, if affiliates would like to invite FDA subject experts to speak. Since the AV library no longer exists, Delegates also discussed how to best organize, preserve and promote the recorded webinars. A new Media Task Force is under force to replace the AV library. This may include webinar-related initiatives.

**Election of Affiliate Council Secretary:** Tori announced that Turonda Crumpler agreed to stand for nomination as the 2013-2014 Affiliate Council Secretary. Turonda provided a brief summary of her professional experience, accomplishments and hobbies. She thanked the delegates for the nomination. Tori asked for any nominations from the floor. Having no other nominations, it was moved and seconded to elect Turonda, who was voted by acclamation.

**Presentation of the Affiliate Awards:** Tori Stivers highlighted the achievements of the award winners and presented the 2013 Affiliate Awards to the following:

Florida also won the *C. B. Shogren Memorial Award*, which will be presented at the Awards Banquet on July 31, 2013.

**New Business:** Stephanie Olmsted, a long-time Washington State Delegate, has moved to Northern California.

**Affiliate Reports:** Delegates/representatives who did not need to leave for other meetings gave two-minute oral summaries of their respective Affiliate's activities in 2012, including the number of active members, the number of general membership meetings hosted, biggest challenges, and biggest successes.

**Final Comments:** Isabel Walls provided a short report on the various activities associated with the global food safety capacity building efforts. The Affiliates can help with providing subject

matter experts in assisting the training efforts. She suggested that if individuals are interested in learning about or helping with these activities, please contact her at Isabel.walls@osec.usda.gov.

#### Recommendations to Executive Board:

1. Offer subtitles to the webinars in various languages, depending on relevancy to ethnic groups. Webinars can be broadcast as a Podcast.
2. IAFP meeting announcement to include the day of the Welcome Reception (typically a Saturday). This is to allow the IAFP participants to get the approval from their government employers to arrive in time to attend the committee meetings the following day.
3. Consider ways to use the recorded webinars as a money-making activity for IAFP (e.g., access to the webinars tied in with IAFP membership).

Abstracts not approved by the program committee may be considered for other meetings. Will such info be included in the IAFP rejection letters to the authors?

**Passing of Gavel:** Chairperson Tori Stivers passed the gavel to Tong-Jen Fu, signifying the beginning of TJ's term as Affiliate Council Chair.
