VIEW FROM THE CHAIR:

Planning for the Future of Your Affiliate



Spring is a time of renewal and new beginnings.

This season heralds renewed possibilities as increasing COVID-19 vaccination rates and decreasing cases of COVID-19 have signaled

a return to more 'normalcy.' Affiliates around the globe have felt this change and started once again to plan onsite meetings – everyone is excited for the chance to see colleagues and friends once more. During the past two years, some Affiliates have hit 'pause,' some have continued meeting through video communications, and some have bravely dared to host an onsite gathering. The decline of this great disruption in our lives gives us the chance to have a new beginning and plan some ambitious goals to help strengthen our organizations.

It should come as no surprise to those who know me that I heartily suggest starting this new chapter with a planning session to create long-term goals and help develop an **Affiliate Strategic Plan** (see my past columns on this plan). The Georgia Affiliate is proof that this can be effective. A little more than a decade ago, our Affiliate was truly struggling. We were finding it hard to find engaged board members; our membership was decreasing; our scholarship program had lapsed; and every meeting

seemed to come together at the last minute. I give all the credit to Tori Stivers and Mark Norton for holding things together during that time, until we were finally able to find a few individuals who were interested in turning things around. A new board was formed that decided to hold a strategic planning session. The goals which were created during that session provided the framework for slow but continued progress and growth. Today, the Georgia Association for Food Protection is as strong as it's ever been – and it just might be time again for another strategic plan to keep this continuous improvement and growth!

Every Affiliate is different, and their planning will reflect their goals. Here are a few goals that helped GAFP achieve its new beginning:

Create and maintain a strong board: Proactively seek out candidates; schedule monthly board calls; and distribute the work equally among board members.

Explore collaborative partnerships: Hold joint meetings with similar organizations; find new ways to add value to the Membership; expand our marketing; and increase sponsors.

Expand, encourage, and engage membership: Revise an old website; develop a communications platform; find advertising partners; and create committees.

Expand student involvement: Restart the student scholarship program; create the student liaison position; recruit students and faculty from multiple universities; and create focused meetings for students, i.e., the 3-Minute Thesis Competition, student speakers, etc.

Improve meetings: Find innovative and/or free venues to save money; diversify time/location/length of meetings; and recruit great speakers.

As we discuss changes and new beginnings, I want to ensure that everyone is aware of a proposal that's currently under debate among the Affiliate groups. This has the possibility to cause a large change, not only with the Affiliate Council (AC), but with the IAFP Executive Board as well. This is a proposed extension of the Affiliate Council Secretary and Chairperson terms from one year each (total of two years) to two years each (total of four years). Currently, a new AC Secretary is elected during the Affiliate Council Meeting (at the IAFP Annual Meeting) to begin their term at the conclusion of the Annual Meeting. They then become an ad-hoc (non-voting) member of the IAFP Executive Board for one year. The current Secretary moves to the position of AC Chairperson and becomes a full Member of the IAFP Executive Board for the year they serve, while the former AC Chairperson rotates off and resumes normal membership.

During the most recent Affiliate Council call on March 2, 2022, there was much debate about this proposed change, with compelling points made on each side. Those in favor of extending the terms believe it would create more consistency and continuity in leadership, promote more progress on AC goals, and allow the AC Chairperson to add more value to both the AC and the IAFP Executive Board. Those opposed are concerned this change would limit opportunities for participation on the IAFP Executive Board, and that extended terms may interfere with some Delegate elections within their respective Affiliate. The IAFP Executive Board has no objection with the proposed term extension, but this change must be approved by the Affiliate Council (and then accepted by the IAFP Executive Board). We will vote on this proposal as a change to the AC Operational Guidelines (along with other necessary changes) during our July 31 Affiliate Council Meeting onsite in Pittsburgh, Pennsylvania. I urge all Affiliate Delegates to try to attend this meeting to ensure your opinions are heard before voting on this significant change.

Continue to stay safe, and I hope to see you on our next virtual Affiliate Council conference call on Thursday, May 19, at 6:00 p.m. *(Eastern Time)* and in person at IAFP 2022. This year's Silent Auction returns, so please consider donating an item(s) to be part of this lively event. We've always received such a great response from state-/provincial-/regional-themed donations in the past, including unique and one-of-a-kind items you can't find anywhere else. And remember, all proceeds help fund the IAFP Foundation!

California Association for Food Protection: Affiliate Development Continues Reported by Laurie Clotilde, President



The California Association for Food Protection (CalFP) continues developing its organization as COVID-19 has delayed large in-person

meetings. The Affiliate in Fall 2021 co-sponsored a meet-and-greet event in the Bay Area with the Pacific Southwest AOAC group.

With limited success with webinars, the Affiliate is planning small in-person regional events and one larger statewide meeting later in 2022. We will also work with the Northern California Branch of the American Society for Microbiology in developing and hosting meetings.

Work has continued with our attorney and accountant to finalize our non-profit status with the state and federal governments, a slow development. In that process, we are looking to update and simplify the Bylaws with attorney review. Our treasury is solid for a new organization and slowly growing.

The CaIFP website has been a resource of information and membership registrations.

Membership has been slowly growing, and we expect a significant growth once we begin inperson events. We feel fortunate to have a wealth of potential speakers and sponsors based in California, and many have committed to support us.

Along with meeting in person, we look to develop more active committees to advance the organization in 2022, as well as our election of new Officers.

AFFILIATE NEWS

SECOND AFFILIATE COUNCIL STRATEGIC PLANNING MEETING HELD VIRTUALLY

The Affiliate Council held its second Strategic Planning Meeting virtually on March 2, 2022 from 12:00 p.m.–1:00 p.m. (Eastern Time). The purpose of this meeting was to continue discussion of the Affiliate Council Strategic Plan in more detail and gain input from attendees.

Affiliate Council Chair Wendy White opened the meeting to approximately 45 attendees with a reminder about submitting Annual Reports by the deadline. The following discussion topics took place:

Board Continuity Discussion

After prior discussions, a proposal to extend Affiliate Council leadership (Secretary and Chair) terms from two years total to four years total was introduced during February's IAFP Executive Board meeting with no objections. This proposed change will require amendment to the Affiliate Council's Operational Guidelines. Voting on this change will take place at the Affiliate Council Meeting on July 31 in Pittsburgh, Pennsylvania.

This proposed change was brought up for discussion during the November 2021 Affiliate Council call as a way to accomplish the goals set forth in the Strategic Plan and to add continuity to the Affiliate Council leadership. Attendees discussed pros and cons for this proposed change:

The counter argument warned that longer term limits would allow fewer people to experience the benefits of leadership, specifically exposure to the IAFP Executive Board. There was also concern that going from a total of two years to a four-year commitment would be too long for some people.

Encouraged soliciting further discussion through IAFP Connect.

Best Practice Sharing

- Student Involvement
- Encouraging student involvement with the different Affiliates – what are we doing; what is working?
- Susan Smith stated there is more involvement now than in the past but we still need more ways to encourage involvement.
- o (Unidentified speaker) talked about the success

they've had with the position of Student Liaison and having that person take an active part on the board.

- Some Affiliates have asked students to oversee their social media communications with much success.
- Other ideas:
- Free membership instead of a student fee
- Place grad students on the board or as an Ad Hoc to the board
- Have students present their thesis as a video conference during a meeting
- Assign an Affiliate Student Liaison
- Create and award scholarships
- Invite one faculty member (paid Affiliate Member) to the Affiliate's Annual Conference and allow them to bring three students for free
- Offer a poster session at a meeting/conference for anyone who presented at IAFP's Annual Meeting as the work is already complete and gives them another forum in which to present
- Need to build a better bridge between the Affiliate board and the Student PDG
- Provide some benefits to the student summer internship, training courses not offered as part of their curriculum (i.e., BRC, IFS, Design Thinking)

Discussion Topic

- For in-person meetings, do any Affiliates require a COVID-19-related form to be completed, temperatures to be checked, etc.?
- Some yes, some no
- Some government employees have a requirement
- Depends state by state and what the expectations are

Discussion Topic

 Do any Affiliates offer CEs? Topic was tabled until next meeting due to time.

EXECUTIVE BOARD WELCOMES INCOMING SECRETARY

Congratulations to **Dr. Manpreet Singh,** who was recently elected to the IAFP Executive Board as Secretary. Dr. Singh is a Professor and Department Head for the Department of Food Science and Technology at the University of Georgia (UGA) on the Athens campus.



Dr. Singh's research over the years has focused on persistence, prevalence, and transmission of foodborne pathogens in food processing environments and processed foods; development and validation of inter-

vention strategies to improve microbial safety of foods; and antimicrobial resistance of foodborne pathogens associated with food animals, specifically poultry. His Extension Program includes teaching processing programs related to FSMA, HACCP, seafood, and validation and verification programs. His current research activities involve international development, specifically in Senegal, focused on the dairy value chain as part of the USAID Feed the Future Innovation Lab for Food Safety.

Dr. Singh has attended nearly every Annual Meeting since joining IAFP in 2001 and has organized, convened, and presented several IAFP symposia. His involvement with IAFP includes serving on the *Food Protection* Trends Management Committee (2010-2015), the Journal of Food Protection Editorial Board (2010-2015), and the IAFP Program Committee (2015-2020), serving as its Chair in 2020 for the virtual Annual Meeting. He received the Presidents' Recognition Award in 2013 for his service on the *Food* **Protection Trends** Management Committee. Dr. Singh also served on the Developing **Scientists Award Committee and is currently** on the Webinar Committee, serving a term as Chair. Dr. Singh is a member of several PDGs within IAFP and has been a Member of several IAFP Affiliates throughout his career. He was a co-founding Member of IAFP's Affiliate, the Indian Association for Food Protection in North America (IAFPNA) and served as its treasurer for two years. In addition, he has consistently supported international activities of IAFP.

Dr. Singh holds a bachelor's in Agricultural Sciences with a specialization in Food Technology from Punjab Agricultural University in India. He earned his master's in Food Science and Technology from Kansas State University and his Ph.D. in Food Science and Technology from Iowa State University.
